In continuation to the earlier notifications, the stray vacancy round II extended (Off-line) allotment procedure for BDS courses will be carried out by the Board as per schedule given below:

Application form (Registration) Start date for filling of on-line application form and deposition of required application fee It is a mandatory step for subsequent process. Both the parts (Part 1 and Part 2) of the application form must be filled and completed. Candidates who could not complete both the parts (Part 1 and Part 2) of the application form earlier, may also complete the same. Those who are already registered/have applied need not register/apply again. However, their participation in Stray vacancy round II extended shall be subject to their eligibility. Candidates who exited with forfeiture of security amount in Round 2 allotment and not registered earlier may apply again subject to their eligibility for participation in Stray vacancy round II Extended. Security Deposit Deposition of security amount For private dental colleges – INR 10000 All candidates eligible to participate in stray vacancy round II and willing, must deposit, if not deposited earlier, on-line INR 10,000/- (for allotment in Private Dental colleges), failing which they will not be considered for admission on a seat in a college in Stray vacancy round II Extended. Seat allotment and Joining Seat allotment on merit along with submission of all original documents before the Board at the venue - RUHS College of Dental Sciences (GDC), Subhash Nagar, Behind T.B. Hospital, Jaipur All concerned eligible candidates who are registered with Rajasthan NEET UG Counselling Board 2023 and willing to participate are required to present themselves alongwith all original educational and eligibility documents, and join by depositing requisite fee on-line and by completing other formalities at the spot, if allotted.	30.10.2023, 10.00 am

1. Refer information booklet, college information sheet and college fee structure etc. and other information at the website. Regarding fee, also refer order dated 19.05.2022 of Hon'ble Supreme Court in civil appeal no. 3978-3995/2017.
2. Candidates required to fill application form must deposit non-refundable application fee of INR 2000/- (INR 1200/- for SC, ST, ST-STA category candidate of Rajasthan state domicile as well as candidate of Rajasthan state domicile whose family annual income is less than INR 2.5 lacs) + applicable transaction charges.
3. The candidates are advised to visit these websites regularly for all relevant information.
4. All registered candidates who are eligible and wish to participate in stray vacancy round II extended off-line counseling must present themselves personally before the Board on the designated place, date and time.
5. A candidate allotted a seat in stray vacancy round II extended does not join the allotted seat shall be debarred from participating in the State counseling process for next one year, alongwith forfeiture of security amount.
6. No candidate will be allowed to resign from the State Quota seats after joining in round 3 as well as in stray vacancy round/s or having status as 'Joined'.
7. **Submission of original documents:** All candidates who wish to participate in stray vacancy round II extended off-line counseling must bring all the original documents and undertaking (as given in the instruction booklet available at the website).

In stray vacancy round II extended off-line counseling, a candidate who gets allotment shall deposit his/her original document alongwith undertaking.

8. Eligibility

- Round 3 allotted / upgraded candidate is not eligible to participate in stray vacancy round II Extended.
- Stray vacancy round I candidate allotted a seat on 29.09.2023 (MBBS / BDS course) is not eligible to participate in stray vacancy round II Extended.
- Stray vacancy round II candidate allotted a seat on 13.10.2023 (BDS course) is not eligible to participate in stray vacancy round II Extended.
- A candidate who has already joined a seat allotted through Rajasthan state counselling / any other state counselling including all India counselling is not eligible to participate in stray vacancy round II Extended.
